COUNTY OF VOLUSIA'S OBJECTION TO THE "RESTRICTIVE AMENDMENT" TO ORIGINAL WASTEWATER CERTIFICATE AND COUNTY OF VOLUSIA'S REQUEST FOR STATUS CONFERENCE

Volusia County hereby objects to the Restrictive Amendment, dated December 27, 2011, Florida Public Service Commission Clerk, to the Application for Original Wastewater Certificate filed by Farmton Water Resources, LLC, (hereafter referred to as "Farmton") and requests a status conference concerning the issues in this matter, stating in support thereof:

OBJECTION TO RESTRICTIVE AMENDMENT AS FILED

1. The County of Volusia is a body corporate and politic and is a duly organized political subdivision of the State of Florida. The County of Volusia has a substantial interest in the outcome of this application as more particularly set forth herein.

2. The County of Volusia filed a timely objection to the original Farmton Wastewater Application on November 28, 2011 (the "Objection"). A copy of the Objection, without exhibits, is attached hereto as Exhibit "A" and incorporated as if fully stated herein.

3. On December 27, 2011, Farmton filed a letter with Exhibits which was represented to be a restrictive amendment to the original application (the "Restrictive Amendment." The purported intent of the restrictive amendment filing was to exclude lands

within Volusia County from the proposed wastewater service area. A copy of the Restrictive Amendment is attached hereto as Exhibit "B."

4. It is the position of Volusia County that the Restrictive Amendment, as currently filed, is insufficient and incompatible with the newly offered exhibits. For example, the introduction to the application and the associated engineering reports still references the operation of a wastewater utility in "Volusia and Brevard Counties." Within the engineering reports, tables concerning wastewater flow, ERC and capacity projections and development entitlements still contain references to Volusia or data computations that assume Volusia County's inclusion in the service area.

5. Volusia County requests that the Restrictive Amendment be further amended so that all references to Volusia County are removed from the Wastewater Certificate application and all associated exhibits, including but not limited to the engineering reports. Moreover, all computations in the Farmton wastewater certificate application and associated exhibits which originally allowed for the inclusion of Volusia County lands must be revised to reflect Brevard County only.

REQUEST FOR STATUS CONFERENCE

Volusia County requests a status conference in furtherance of its good faith efforts to resolve this matter.

Pursuant to Rule 25-30.031 of the Florida Administrative Code and Sections 120.569, 120.57 and 367.045, Florida Statutes (2011), the County of Volusia objects to the Notice for an initial Certificate of Authorization for Wastewater Certificate (Document Number 07982-11, dated October 28, 2011, Florida Public Service Commission Clerk) and to the Application for Original Wastewater Certificate (Document Number 07914-11, dated October 27, 2011, Florida Public Service Commission Clerk) filed by Farmton Water Resources, LLC, (hereafter respectively referred to as the Farmton Notice and Farmton Application) and requests an administrative hearing and says in support thereof:

OBJECTION TO FARMTON NOTICE AND FARMTON APPLICATION

1. The County of Volusia is a body corporate and politic and is a duly organized political subdivision of the State of Florida. The County of Volusia has a substantial interest in the outcome of this application as more particularly set forth herein.

2. The County of Volusia objects to the Farmton Application as there is no immediate or imminent need for central wastewater service in the proposed Volusia County service area. The Farmton Local Plan was adopted by the County of Volusia on April 7, 2011. A copy of the Farmton Local Plan is attached hereto as Exhibit "A" and incorporated as if fully stated herein. The Farmton Local Plan states that "no building permit shall be issued for new development within the SDA (Sustainable Development Area) districts within five (5) years of the effective date of the Farmton Local Plan." Moreover, no development may occur outside the Gateway District of the Farmton Plan until 2025. The Gateway District is not included in the legal description of the lands subject to the Farmton Application. However, the Farmton Application legal description does erroneously include thousands of acres of land that is subject to permanent preservation under the Farmton Local Plan's GreenKey land use designation. This acreage will never need wastewater service. Thus, the Farnton Application is, at best, extremely premature and inconsistent with the Farmton Local Plan and the five year review provisions of Section 367.111(1), Florida Statutes.

3. The County of Volusia objects to the Farmton Application as Farmton Water Resources, LLC does not have the technical ability to provide service. The applicant only holds a single certificate for a potable water utility and is not a retail wastewater utility service provider. The applicant employs no individuals capable of operating or offering consultation on the operation of wastewater transportation and treatment operations. Contracting with a utility operator will serve to increase the cost of service, which is contrary to the public interest.

4. The County of Volusia further objects to the Farmton Application on the basis that the proposed wastewater certificate, if granted, would adversely impact the County and its ability to effectively expand and implement its wastewater services within the County.

5. The County of Volusia further objects to the Farmton Application for Wastewater Certificate on the basis that the proposed utility does not meet the requirements of Section 367.045, Florida Statutes, because the applicant has not proven its ability to provide service, the need for service or the nonexistence of service from other sources.

PETITION FOR ADMINISTRATIVE HEARING

Pursuant to Sections 120.569, 120.57 and 367.045(4), Florida Statutes (2011), Volusia County requests a hearing on the objection stated herein. The County of Volusia incorporates herein paragraphs 1 through 5.

WHEREFORE, Volusia County requests a hearing pursuant to Sections 120.569, 120.57(1), and 367.045, Florida Statutes 2011 and denial of Farmton's Application.
