Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Gulf Power Company requests confidential classification of certain highlighted information provided in its Revised Form 423 filings for January and February, 2011, filed 2/07/2012. Staff notes that these "revised" filings essentially replace the original Form 423 filings for January and February, 2011.

Staff has reviewed Gulf Power Company's confidentiality request. In staff's opinion, the requests meet the criteria for confidentiality contained in Section 366.093, Florida Statutes. Therefore, staff recommends that the request for confidentiality of certain information included in Document Nos. 00733-12 and 00736-12 be approved.
