On January 26, 2012, Peoples Gas System (Peoples) filed its request for confidential classification for Document No. 00537-12. This document is a special gas transportation agreement between Peoples and Peninsula Pipeline Company. The information in the agreement for which Peoples seeks confidential treatment relates to the charges at which Peoples will provide gas service to Peninsula. Staff has reviewed the document and concurs with Peoples that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm Peoples' competitive business operations.

Therefore, staff recommends that Peoples' request for confidential classification of Docket No. 00537-12 be approved.
