


This letter is to provide an update on the status of negotiations that have occurred in this matter among Equity LifeStyle Properties, Inc., ("ELS"), Pasco County ("County"), and the City of New Port Richey ("City") and to request the Florida Public Service Commission ("FPSC") to proceed to process the December 14, 2011, ELS motion to dismiss the objections filed by the City and County.

Representatives from ELS met with representatives of the City on January 24, 2012, to discuss possible resolution of the City's (and County's) objection. As a result of the discussions on the 24<sup>th</sup>, ELS also provided to the City additional information relevant to the City's decisionmaking. This information was received by the City on February 2, 2012. To date, the City has not provided further substantive communications to ELS on this matter.

ELS previously filed a motion to dismiss the City's (and County's) objections, but requested that the motion be held in abeyance while discussions have been pending. Although ELS appreciates the discussions it has had with the City and County on this matter, at this time, ELS respectfully requests that the FPSC proceed to rule on its pending motion to dismiss.
