



RE: Tariff Filing – Request for Residential Wastewater Only Rates

Aqua Utilities Florida, Inc. (AUF) hereby requests approval of the attached tariff filing for residential wastewater only (RWO) monthly service rates pursuant to Section 367.091(5), Florida Statutes.

In accordance with Section 367.091(5), F.S., AUF submits the following information. . In its last rate case in Docket No. 100330-WS, AUF requested approval of uniform residential wastewater only service rates for all systems owned and operated by the utility company. These requested rates would apply to all wastewater systems uniformly. Subsequently Order No. PSC-12-0102-FOF-WS (Final Order), was issued on March 5, 2012. In its Final Order, the Commission approved residential wastewater rates for only certain systems within each wastewater rate band. However, it did not address the remaining systems contained in each rate band. AUF believes it is necessary to have a single residential wastewater rate approved for all systems contained within each rate band to be applied to all systems contained therein.

Residential AUF customers have installed private wells for potable water service. Most recently, a residential customer installed and connected a private water well to a residence without informing the utility company. This installation occurred in an AUF system that did not have a tariff approved for RWO service. The customers within this system are provided both water and wastewater service by AUF. Up until the time the private well was installed, AUF billed this customer the approved rates contained in its tariffs. These charges contained the COM standardized base facility and gallonage charges for both water and wastewater based on the water consumption recorded through the water meter. Upon the determination that a private yell had been connected to the residential home, AUF removed the water meter due to the potential cross connection. Consistent with Department of Environmental Protection (DEP) CCL rules, and AUF's approved Cross Protection Policy, the water meter had to be removed to protect RAD The potable water supply to the water distribution system and remaining customers. Upon removal of the customer's water meter, AUF currently has no Commission approved residential wastewater only (RWO) rate to charge the customer within this wastewater system.

AUF utilized the Commission Staff's wastewater rate calculations contained in the staff's Excel workpapers to calculate and propose RWO rates to be charged to all systems contained in each respective wastewater rate band. The proposed RWO rates were calculated utilizing the Commission approved base facility charges and gallonage charges for Wastewater Rate Band 1 and Wastewater Rate Band 2. The gallonge charge was applied to the average residential wastewater consumption calculated by the Commission staff in its workpapers.

AUF believes the phenomenon of residential customers installing private wells to utilize for potable water has become much more prevalent and is no longer isolated incidences. AUF has recently experienced these situations with much more frequency within other systems throughout Florida. When this situation occurs where both water and wastewater service is provided to residential customers, it is imperative that a RWO rate is approved for charging these customers for the provided wastewater service to protect the remaining general body of wastewater ratepayers.

For the specific customer referenced above, AUF has noticed the customer that the requested RWO rate would be charged consistent with Section 367.091(5), Florida Statutes. AUF will continue to charge this requested rate consistent with the referenced statute until such time as the Commission approves an appropriate RWO rate for all systems contained in each wastewater rate band.
