- 1. On May 17, 2012, AT&T Florida served its Responses to the Staff of the Florida Public Service Commission's ("Staff's") First Set of Interrogatories (Nos. 1-5), dated May 7, 2012.
- 2. Portions of AT&T Florida's response to Staff's First Set of Interrogatories Nos. 2(a) and 2(c) contain customer specific network information that may be considered confidential and proprietary to Halo Wireless, Inc. ("Halo").
