Dear Ms. Cole:

In its November 18, 2011 Order reforming the intercarrier compensation and universal service systems (26 FCC Rcd 17663), the Federal Communications Commission adopted a rule requiring federal Price Cap Carriers to certify to the FCC and relevant state commissions that they are not seeking duplicative recovery in the state jurisdiction for any Eligible Recovery subject to federal recovery mechanisms. *See* 47 C.F.R. § 51.915(d)(3). In compliance with that requirement, attached for filing is Verizon's certification, which was filed with the FCC on June 20, 2012.
