I concur with and adopt the initial and preliminary position stated earlier today by the Office of Public Council (OPC) and the Florida Retail Federation (FRF) in response to the Joint Motion to Suspend Procedural Schedule ("Motion to Suspend") filed by Florida Power & Light, South Florida Hospital and Health Care Association (SFHHA), Florida Industrial Power Users Group (FIPUG), and Federal Executive Agencies (FEA) (collectively "FPL") on August 15, 2012.

I state that I do not oppose the Motion at this time only to the extent that it requests the Commission to suspend the hearing currently scheduled to begin on August 20, 2012 in the Docket and establish procedures and time frames adequate to provide due process to all parties.

I agree with the concerns about timing and protecting the rights of all parties as expressed by OPC and FRF, and for this reason do not oppose suspension of the hearing.
