AMENDMENT TO INTERCONNECTION AGREEMENT BY AND BETWEEN BELLSOUTH TELECOMMUNICATIONS, LLC D/B/A AT&T ALABAMA, AT&T FLORIDA, AT&T GEORGIA, AT&T KENTUCKY, AT&T LOUISIANA, AT&T MISSISSIPPI, AT&T NORTH CAROLINA, AT&T SOUTH CAROLINA, AT&T TENNESSEE AND US LEC OF ALABAMA L.L.C., US LEC OF FLORIDA, LLC, US LEC OF GEORGIA LLC (DELAWARE), US LEC OF SOUTH CAROLINA LLC, US LEC OF

The Interconnection Agreement by and between BellSouth Telecommunications, LLC d/b/a AT&T ALABAMA, AT&T FLORIDA, AT&T GEORGIA, AT&T KENTUCKY, AT&T LOUISIANA, AT&T MISSISSIPPI, AT&T NORTH CAROLINA, AT&T SOUTH CAROLINA, and AT&T TENNESSEE ("AT&T") (f/k/a BellSouth Telecommunications, inc. ("BellSouth")) and US LEC of Alabama L.L.C., US LEC of Florida, LLC, US LEC of Georgia LLC (DELAWARE), US LEC of South Carolina LLC, US LEC of Tennessee LLC, and US LEC Communications LLC ("US LEC") (f/k/a US LEC of Alabama Inc., US LEC of Florida Inc., US LEC of South Carolina Inc., US LEC of South Carolina Inc., US LEC of Communications Inc.) is hereby amended as follows.

TENNESSEE LLC. AND US LEC COMMUNICATIONS LLC

WHEREAS, AT&T and US LEC of Alabama Inc., US LEC of Florida, Inc., US LEC of Georgia Inc., US LEC of North Carolina Inc., US LEC of South Carolina Inc., US LEC of Tennessee Inc. and US LEC Communications Inc. are the parties to that certain "Interconnection Agreement" approved as of December 28, 2006 (the "Agreement"); and

WHEREAS, US LEC of Alabama Inc. has changed its name to US LEC of Alabama L.L.C., US LEC of Florida Inc. has changed its name to US LEC of Florida, LLC, US LEC of Georgia Inc. has changed its name to US LEC of Georgia LLC, US LEC of North Carolina Inc. has changed its name to US LEC of South Carolina Inc. has changed its name to US LEC of Tennessee Inc. has changed its name to US LEC of Tennessee LLC, and US LEC Communications LLC and they wish to reflect these name changes as set forth herein.

NOW, THEREFORE, in consideration of the mutual promises contained herein, AT&T and US LEC hereby agree as follows:

- The Agreement is hereby amended to reflect the name changes from US LEC of Alabama Inc. to US LEC of Alabama L.L.C., from US LEC of Florida Inc. to US LEC of Florida, LLC, from US LEC of Georgia Inc. to US LEC of Georgia LLC, from US LEC of North Carolina Inc. to US LEC Communications LLC, from US LEC of South Carolina Inc. to US LEC of South Carolina LLC, from US LEC of Tennessee Inc. to US LEC of Tennessee LLC, and from US LEC Communications Inc. to US LEC Communications LLC.
- 2. AT&T shall reflect that name change from US LEC of North Carolina Inc. to US LEC Communications LLC only for the main billing account (header card) for each of the accounts previously billed to US LEC of North Carolina Inc. AT&T shall not be obligated, whether under this Amendment or otherwise, to make any other changes to AT&T's records with respect to those accounts, including to the services and items provided and/or billed thereunder or under the Agreement. Without limiting the foregoing, US LEC Communications LLC affirms, represents, and warrants that the ACNA and OCN for those accounts shall not change from that previously used by US LEC of North Carolina Inc. with AT&T for those accounts and the services and items provided and/or billed thereunder.
- 3. Once this Amendment is effective, US LEC of North Carolina, Inc. shall operate with AT&T under the US LEC Communications LLC name for those accounts. Such operation shall include, by way of example only, submitting orders under US LEC Communications LLC and labeling (including re-labeling) equipment and facilities with such name.

- 4. US LEC Communications LLC is responsible for paying normal applicable service order processing/administration charges and/or nonrecurring charges for each service order submitted by US LEC Communications LLC, or by AT&T on behalf of US LEC Communications LLC, for updating billing accounts and End User records.
- 5. This Amendment shall not modify or extend the Effective Date or Term of the underlying Agreement, but rather, shall be coterminous with such Agreement.
- 6. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
- 7. <u>Reservation of Rights</u>. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
- 8. This Amendment shall be filed with and is subject to approval by the State Commission and shall become effective ten (10) days following approval by such Commission.
