## Case Background

Sunrise Utilities, LLC (Sunrise or Utility) is a Class C utility serving approximately 234 water customers in Polk County. The Utility's service area is located in the Southwest Florida Water Management District. The Utility provides water service to 244 residential customers. Sunrise's 2011 annual report indicates total gross operating revenues of \$64,486 and a net operating income loss of \$9,544.

On November 13, 2012, the Utility filed an application for approval of a tariff amendment to charge customers who opt to pay their water bill by debit or credit card. Sunrise filed the tariff sheet for this request on November 28, 2012. This recommendation addresses the

## **Discussion of Issues**

<u>Issue 1</u>: Should the Commission suspend Sunrise's proposed tariff to establish a charge for customers who opt to pay their water bill by debit or credit card?

**Recommendation**: Yes. Sunrise's proposed tariff to establish a charge for customers who opt to pay their water bill by debit or credit card should be suspended to allow staff sufficient time to review the Utility's cost justification. (Bruce)

<u>Staff Analysis</u>: Pursuant to Section 367.091(6), F.S., the Commission may withhold consent to operaton of any or all portions of new rate schedules by a vote to that effect within 60 days, giving a reason or statement of good cause for withholding its consent. Staff is recommending that the tariff be suspended to allow staff sufficient time to review the application and gather all pertinent information to present the Commission an informed recommendation on the proposed tariff. Staff believes that this reason is a good cause consistent with the requirement of Section 367.091(6), F.S.
