Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company requests confidential classification of highlighted information on pages 12 and 14 of Exhibit JBC-1, attached to the Direct Testimony of J.
