Quantum Tele Communications (Texas), Inc. (hereinafter referred to as “QTC”) and Image Access (Louisiana), Inc. (hereinafter referred to as “Image”) (referred to jointly herein as the “Parties”), hereby notify the Commission of a transaction that occurred on March 4, 2013 in which QTC acquired Image through a stock and asset purchase.

It is the Parties’ understanding that no prior Commission approval of this transaction is required as both entities are telecommunications certificate holders in good standing in the State of Texas. Consistent with the representations herein, on April 22, 2013, the appropriate filings regarding this transaction were made with the FCC.
