## PETITION FOR EXPEDITED REVIEW OF GROWTH CODE DENIAL

AT&T Corp ("AT&T"), pursuant to 47 C.F.R. § 52.15(g)(iv), Federal Communications Commission ("FCC") Order FCC 00-104, and Florida Public Service Commission ("Commission") Order No. PSC-01-1973-PCO-TL, petitions the Commission to review the Pooling Administrator's ("NeuStar") denial of AT&T's request for additional numbering resources in the Tallahassee exchange. In support of this petition, AT&T states:

## PARTIES

AT&T is a corporation organized and formed under the laws of the State 1. of New York and a competitive local exchange company ("CLEC") regulated by the Commission and authorized to provide local exchange telecommunications in the State of Florida.

NeuStar is an independent non-governmental entity, which is responsible 2. for administering and managing the numbering resources in pooling areas. See 47 C.F.R. § 52.20(d).

### **JURISDICTION**

The Commission has jurisdiction of this matter pursuant to Irdustry 3. Numbering Committees (INC) Number Pooling Guidelines Sections 3.7 and 12(c). This

provision provides that a carrier may challenge NeuStar's decision to deny numbering resources to the appropriate regulatory authority.

## **BACKGROUND AND REQUEST FOR RELIEF**

4. The Perrine exchange consists of one switching entity that utilize numbering resources: Main (MIAMFLACCMD).

5. On May 7, 2013, AT&T requested additional numbering resources from NeuStar for the Main (MIAMFLACCMD) switch. See Attachments 1. Specifically, AT&T requested a block to meet the request of a specific customer for 1,000 consecutive numbers. The format of the block needs to be in the format of NPA-NXX-2XXX, 7XXX, or 8XXX.

6. At the time of the code request, the Perrine exchange had a MTE of 2.24 and a utilization of 58.7%.

7. On May 7, 2013, NeuStar's denied AT&T's request for additional numbering resources because AT&T had not met the utilization based criteria, notwithstanding the fact that AT&T is unable to provide the numbering resources requested by the specific customer. <u>See Attachment 1</u>. Pursuant to Commission Order No. PSC-01-1973-PCO-TL, attached to this Petition is the customer's contact information. <u>See Attachment 2</u>.

8. As discussed above, both the FCC Order and the INC guidelines provide that state regulatory authorities have the power and authority to review NeuStar's decision to deny a request for numbering resources. <u>See</u> INC Number Pooling Guidelines Sections 3.7 and 12(c).

9. Under earlier MTE procedures used by NANPA, waivers or exceptions were granted when customer hardships could be demonstrated or when the service provider's inventory did not have a block of sequential numbers large enough to meet the customer's specific request. Under existing procedures, NeuStar or NANPA looks at the number of MTE and utilization for the entire rate center without exception. The current process is arbitrary and results in (1) decisions contrary to the public interest and welfare of consumers in the State of Florida; and (2) decisions that do not necessarily promote the efficient use of telephone numbers.

10. AT&T requests that the Commission reverse NeuStar's decision to withhold numbering resources from AT&T on the following grounds:

(a) NeuStar's denial of numbering resources to AT&T interferes with AT&T
Florida's ability to serve its customers within the State of Florida.

(b) As a result of NeuStar's denial of AT&T's request for additional numbering resources, AT&T will be unable to provide telecommunications services to its customers as required under Florida law.

WHEREFORE, AT&T requests:

1. The Commission review the decision of NeuStar to deny AT&T's request for additional numbering resources for the Perrine exchange; and

2. The Commission direct NeuStar to provide the requested numbering resources for the Perrine exchange as discussed above.




