

On June 3, 2013, Tampa Electric Company (TECO) submitted a revised response to OPC's First Request for Production of Documents No. 3, Bates stamp page 5873. The original Document No. 02522-13 and the revised Document No. 03035-13 were transmitted as confidential documents.

TECO requests confidential classification of the information contained in the above-referenced document that it treats as propriety confidential business information. The information contains proprietary compensation agreements and incentive plans of TECO, and the disclosure of this sensitive information would adversely affect its ability to negotiate labor agreements. The information relates to competitive interests and the disclosure would impair the company's business interest by diminishing its ability to contract future labor agreements at favorable terms.

TECO states that the requested information is entitled to confidential treatment and seeks to keep it confidential pursuant to Section 366.093, Florida Statutes (F.S.) and Rule 25-22.006(4), Florida Administrative Code. Staff has reviewed the information and believes that it meets the requirements for confidential classification, and that the disclosure of this information should be exempt under Section 119.07, F.S.
