On May 28, 2013, Tampa Electric Company (TECO) filed a request for confidential classification of the highlighted information contained in Document Number 02922-13, Bates Stamp Pages 111-A001 through 112-A-71. Such documents were filed in response to Staff's 1st Request for Production of Documents, Nos. 1-6. TECO states that the information contained in the highlighted portions of these documents should be classified as proprietary confidential business information pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code.

Specifically, TECO requests confidentiality of highlighted portions of Bate Stamp Pages 11-A-001 through 112-A-71 and 340, which TECO states is contractual proprietary work product of TECO's consultant, Moody's Analytics, based on Section 366.093(3)(a), "trade secrets", and Section 366.093(3)(e), "information related to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." TECO also requests confidentiality of highlighted portions of Bate Stamp Pages 258-296, which contains customer specific account information, based on Sections 366.093(3)(d) and (e). Section 366.093(d) is proprietary business information which includes "information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms."

Upon review of the aforementioned documents, staff concurs with TECO that the highlighted information contained in Document Number 02922-13 meets the requirements for confidential classification pursuant to Sections 366.093(3)(d) and (e). Accordingly, this information should be treated as confidential.
