On behalf of CTC Communications Corp. d/b/a EarthLink Business ("CTC"), DeltaCom, LLC d/b/a EarthLink Business ("DeltaCom"), EarthLink Carrier, LLC ("ELink Carrier"), EarthLink Business, LLC ("ELink Biz"), Saturn Telecommunication Services, Inc. d/b/a EarthLink Business ("Saturn") and STS Telecom, LLC ("STS") (collectively, the "Parties"), this letter notifies the Commission that, except for the *pro forma* transfer of certain wholesale network assets and customers of DeltaCom to ELink Carrier, the *pro forma* intra-company changes described in the Parties' Notification electronically filed on November 9, 2012 (the "Notification"), were completed on December 31, 2012.

As a result of the *pro forma* mergers described in the Notification, Saturn<sup>1</sup> and STS<sup>2</sup> no longer exist as separate corporate entities. Therefore, DeltaCom, as their successor in interest, request that the Commission cancel CLEC Certificate No. 8251 and IXC Registration No. TI292 of Saturn and CLEC Certificate No. 8416 and IXC Registration
