Re: Docket No. 130178-SU, Application for staff-assisted rate case in Polk County by Crooked Lake Park Sewerage Company.

Dear Mr. Garrard:

We have determined eligibility for staff assistance in the above referenced case filed by Crooked Lake Park Sewerage Company (Crooked Lake or Utility). We find that the Utility is eligible for the staff assisted rate case (SARC) filing.

The staff engineer has determined the filing fee in this rate case is \$1,000. The fee is based on the capacity of the Utility's systems as provided by Section 367.145(2) of the Florida Statutes (F.S.). The filing fees must be received by August 26, 2013, which is the official filing date for this rate case. Pursuant to Rule 25-30.456(9), Florida Administrative Code (F.A.C.), the Commission shall deny the application if a utility does not remit the fee within 30 days after official acceptance, as provided by Section 367.145, F.S., and paragraph 25-30.020(2)(f), F.A.C.

Section 367.091(2), F.S., provides:

Upon filing an application for new rates, the utility shall mail a copy of the application to the chief executive officer of the governing body of each county within the service areas included in the rate request. The governing body may petition the commission for leave to intervene in the rate change proceeding and the commission shall grant intervenor status to any governing body that files a petition.

Please forward a copy of Crooked Lake's application for a SARC to the Chief Executive Officer of Polk County as required by law, and copy the Commission as proof that an application was forwarded to them.


