On August 29, 2013, pursuant to Section 366.093, Florida Statutes (F. S.), Duke Energy Florida, Inc., filed a request for confidential classification with respect to the highlighted information contained in Document Number 05099-13: Certain information contained in the supporting documentation to risk management plan for interest rate derivatives for 2013. PEF states that the information contained in these documents should be classified as proprietary, confidential business information pursuant to Section 366.093(3) (e), F.S.

PEF requests confidentiality under Subsection 366.093(3) (e) F.S., which states:

- (3) Proprietary confidential business information means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers for the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public. Proprietary confidential business information includes, but is not limited to:
  - (e) Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information.

Upon review of the aforementioned documents, staff concurs with Progress Energy Florida, Inc. that the highlighted information contained in Document Number 05099-13 meets the requirements for confidential classification pursuant to Section 366.093(1), (3)(e) and (4). Accordingly, this information should be treated as confidential.
