An over-recovery of \$2,730,783, inclusive of interest.
What are the total purchased gas adjustment true-up amounts to be collected during the period January 2014 through December 2014?
An under-recovery of \$69,405.
What are the levelized purchased gas cost recovery (cap) factors for the period January 2014 through December 2014?
The appropriate PGA factor is 87.198 cents per therm, which includes Peninsula Pipeline capacity costs included in the Company's 2014 projections and anticipated additional upstream supply and capacity to serve new customers in 2014 in Nassau County, Okeechobee County, and Polk County.
