AMENDATORY ORDER

BY THE COMMISSION:

On October 2, 2013, the Commission issued Order No. PSC-13-0447-PAA-TX, directing NeuStar to provide BellSouth Telecommunications, LLC d/b/a AT&T Florida (AT&T Florida) with additional numbering resources for the Miami exchange, Silver Oaks (MIAMFLSODS0) switch. No protest was received in response to that order and Consummating Order No. PSC-13-0501-CO-TX was issued on October 25, 2013. Both orders issued in this docket contain errors, which require correction.

First, the second paragraph on page 1 of Order No. PSC-13-0447-PAA-TX incorrectly stated AT&T Florida requested "a single number block of 1,000 numbers in the format of 786-595-NXXX to meet the request of a specific customer." AT&T Florida requested a full NXX (10,000 numbers) in the format of 786-595-NXXX. Therefore, Order No. PSC-13-0447-PAA-TX is amended to reflect that NeuStar provide AT&T Florida with a full NXX in the format of 786-595-NXXX, for the Miami exchange, Silver Oaks (MIAMFLSODS0) switch, as soon as possible.

Second, due to a clerical error, this matter was incorrectly docketed under company certificate code TX031, instead of company certificate code TL720. As a result, the docket number, and both the Proposed Agency Action and Consummating Order numbers were incorrectly assigned the –TX suffix, instead of the -TL suffix. Therefore, the suffix of Order Nos. PSC-13-0447-PAA-TX and PSC-13-0501-CO-TX are amended to reflect the correct utility suffix, -TL.

It is therefore,

ORDERED by the Florida Public Service Commission that Order Nos. PSC-13-0447-PAA-TX and PSC-13-0501-CO-TX shall be amended as reflected in the body of this Amendatory Order. It is further

ORDERED, that Order Nos. PSC-13-0447-PAA-TX and PSC-13-0501-CO-TX are reaffirmed in all other respects and this correction does not alter any of the conclusions in the body of either order.
