Item 9 is a petition from Florida Public Utilities Company, FPUC, requesting approval of a tariff for the company's newly acquired Ft. Meade Division. The Ft. Meade Division will operate as a new investor-owned natural gas utility in Florida as a division of FPUC. In accordance with the purchase agreement with the City of Ft. Meade, base rates specified in the proposed tariff are the same as the city charged its 1,100 customers and are comparable to the Commission-approved FPUC base rates.

The proposed miscellaneous service charges are the same or less than the City had been charging. Staff believes the proposed rates and charges meet the fair, just, and reasonable criteria of Section 366.06, *Florida Statutes*. Staff recommends approval of the proposed Ft. Meade Division tariff.
