Re: Docket No. 130230-SU – Application for amendment of territory for Certificate No. 300-S in Lee County by Forest Utilities, Inc.

Dear Suzanne:

By this letter Forest Utilities, Inc. provides responses to the following data requests:

1. What is the Lee County wastewater rate for 10” turbine meters for multi-family customers that are not individually metered?

Attached is a page from the Lee County rate resolution showing the charge for ten inch meters.

What gallonage charge does Lee County charge for multi-family customers that are not individually metered?

See attached.

Please provide a Lee County tariff showing the Lee County rates that are comparable to the Forest multi-family rates.

See attached.

2. Please provide the Lee county tariff or rate under which Jamaica Bay is currently receiving bulk wastewater treatment from Lee County and a schedule of payments made by Jamaica Bay to Lee County for the last three years.

Lee County currently charges a multi-family rate to Jamaica Bay. That rate is: \$13.01 base charge per unit + and administrative charge of \$3.28 per unit + \$5.59 per 1000 gallons of

water usage. Attached is a page from the current Lee County rate resolution.

Forest does not have access to a schedule of payments made by Jamaica Bay to Lee County for the last three years.

3. Please refer to your letter dated December 19, 2013 to Sonica Bruce. It appears that the revenue expected to be generated by sales to Jamaica Bay at the proposed multi-family retail rate for 2014 are \$419,794 and the expected additional costs to serve Jamaica Bay are \$110, 720, resulting in additional net revenue of \$319,074. Is this correct?

It is an oversimplification to suggest that there will be "additional net revenue" of \$319,074. Jamaica Bay had and has a contractual obligation to send its flows to Forest, and did send its flows to Forest, prior to diverting those flows to Lee County of June 2010. Forest expanded its wastewater treatment plant to accommodate the anticipated flows from Jamaica Bay. The connection to Jamaica Bay was approved by the PSC and the rate assessed Jamaica Bay was also approved by the PSC. It was a dispute related to this diversion that resulted in the lawsuit that was resolved with the Settlement Agreement. The settlement provides that when the pressure tests are performed (and Forest is confident that the flow requirements will be met) that Jamaica Bay will cause its flows to be treated by Forest again. The multi-family rate which Jamaica Bay will pay to Forest, as agreed upon in the settlement, will actually result in about \$120,000 "additional net revenues" when fairly compared to that revenue rendered to Forest from Jamaica Bay as required by to the Bulk Service Agreement. Forest projects that if Jamaica Bay had sent its flows to Forest in 2012, operating revenue under the Bulk Service Agreement would have been approximately \$300,000. Those same flows, if charged under the multi-family rate, would have resulted in operating revenue of approximately \$420,000. This is a net \$120,000 increase and Forest projects that assumption of ownership of the onsite system within Jamaica Bay will result in \$100,000 in increased expenses, conservatively. That's a "net" increase of approximately \$20,000.

4. Should Forest fail to meet the Flow Requirements by January 10, 2015 as required by Section 3 of the Supplement to Settlement Agreement and Jamaica Bay elect to continue to purchase bulk wastewater treatment from Lee county, will Jamaica Bay be required to pay Lee County an impact fee? If so, in what amount?

It is not known with certainty what the County will do. Previous indications from the County were that an impact fee between 2 and 4 million dollars would have to be paid, and that possibly additional I & I analysis would have to done before Jamaica Bay could become a permanent customer of the County.
