AT&T Services, Inc. on behalf of its affiliate SNET America, Inc. d/b/a AT&T Long

Distance East ("SAI"), applies for authority under Section 214(a) of the Communications Act, as

amended ("the Act"), 47 U.S.C. § 214, and Section 63.71 of the Federal Communications

Commission's ("Commission") rules, 47 C.F.R. §63.71, to discontinue its long distance calling

card service.

As required by Section 63.71(a) and (b) of the Commission's rules, SAI is providing the

following information:

Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (b)(2)):

SAI will no longer offer this service on or after May 15, 2014 subject to Commission authorization of the discontinuance pursuant to 47 C.F.R. § 63.71(c).

Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):

SAI will discontinue this service throughout the United States, including the District of Columbia, Puerto Rico, the U.S. Virgin Islands, Guam, the Northern Mariana Islands, and American Samoa.

Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):

SAI long distance calling card service is a long distance travel card that allows users to place interstate calls by dialing a company-provided toll-free access code or number.

The public convenience and necessity will not be impaired by this service discontinuance because this service is declining in the market as mobile phones have, in most cases, obviated the need for calling card services. In addition to mobile phones, there are other alternatives to calling card services in the market such as pre-paid calling cards and alternate billing services that ensure the public convenience and necessity is not impaired when SAI discontinues its calling card service.

Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71(b)(3):

Given the differences in the consumer and business market segments, SAI elected to send different notifications letters to these customers. Consumer calling card users were notified by letter sent via U.S. Mail on March 27, 2014. Business calling card users were notified by letter sent via U.S. Mail on March 28, 2014. Copies of the letters are attached hereto as Attachment A.

In addition, SAI posted a discontinuance notification in the business services section of its website at <u>http://cpr.att.com/pdf/ldest/Calling Card Service.pdf</u> and placed advertisements in the April 1, 2014 editions of The Hartford Courant and the New Haven Register.

Copies of this Application are being sent, first class U.S. Mail, to the public utilities commissions and governors of the affected states and also to the Special Assistant for Telecommunications to the Secretary of Defense, as required by 63.71(a) of the Commission's rules.

Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):

SAI is a non-dominant long distance carrier.
