**MOTION FOR LEAVE TO FILE  
FINANCIAL INFORMATION UNDER SEAL OF CONFIDENTIALITY**

Cloud Computing Concepts, LLC, d/b/a C3 (“Cloud”), hereby respectfully requests that the confidential financial information provided in accord with its application for Authority to Provide Resale Local Exchange Telecommunications Services within the State of Florida be filed under seal of confidentiality and withheld from public inspection. The financial information which Cloud seeks to file under seal of confidentiality has been placed in a sealed envelope, marked “Confidential Information Subject to Protective Order” and is attached to the instant Motion.

Cloud is a privately-held company. The information produced as part of Cloud’s concurrently filed application for Authority to Provide Resale Local Exchange Telecommunications Service that has been identified by Cloud as “confidential” should not be open to public inspection, because it contains detailed information of a confidential nature regarding Cloud’s financial condition. Release of this information to the public is not essential to the Commission’s review of Cloud’s concurrently-filed application for a Authority to Provide Resale Local Exchange Telecommunications Service and public disclosure of its contents would please the applicant at an unfair business disadvantage.

Public disclosure of the information contained herein that Cloud has identified as confidential would reveal information to the public and Cloud’s actual and potential competitors regarding Cloud’s cash position, liabilities, revenues, expenses, and other data which Cloud considers highly

proprietary and confidential. Public disclosure of such information would materially damage Cloud's competitive and financial positions, and would place Cloud in an unfair competitive disadvantage because Cloud does not have access to similar information of its competitors. Additionally, it is Cloud's general practice to disclose the information provided in its financial statements only to parties who have entered into a confidentiality agreement with Cloud.

For the reasons stated herein, Cloud submits that good cause exists for the Commission to permit the financial information contained herein and submitted with its application for Authority to Provide Resale Local Exchange Telecommunications Services within the State of Florida that has been identified by Cloud as "confidential" to be filed under seal of confidentiality and withheld from public inspection.

WHEREFORE, Cloud respectfully requests that its Motion for Leave to file financial information under seal of confidentiality be granted.
