2 **CHAIRMAN GRAHAM:** Move on to Item Number 15.

3 **MR. GARL:** Commissioners, Item 15 is a
4 petition from Peoples Gas System requesting approval of
5 a special contract with RockTenn CP, LLC, for natural
6 gas transportation service to paper products mills in
7 Panama City, Jacksonville, and Fernandina Beach.

8 The staff recommendation requires an oral
9 modification to correct a scrivener's error on page 3,
10 second paragraph of the staff analysis section, line 5.
11 The number 6.1 should be changed to 16.1, so it reads,
12 "constructed a 16.1 mile, 12-inch pipeline." The
13 proposed contract precludes potential bypass by
14 RockTenn, establishes rates that cover the cost of
15 service, and provides protection for Peoples and its
16 general body of ratepayers. Staff recommends approval.

17 **CHAIRMAN GRAHAM:** Commissioners, any questions
18 of staff on this item?

19 Commissioner Balbis.

20 **COMMISSIONER BALBIS:** Mr. Chairman, I don't
21 have any questions for staff. But with the protections
22 that are in place with this contract, I fully support
23 staff's recommendation and move approval.

25 seconded, staff recommendation on Item Number 15. Any
