On May 12, 2014, Florida Power & Light Company (FPL) filed a request for confidential classification for Document No. 02236-14. On May 23, 2014, FPL filed a request for confidential classification for Document No. 02495-14, which contains some corrections to the request filed on May 12. In both documents, the information for which FPL seeks confidential treatment relates to information concerning bids or other contractual data and information relating to competitive interests. Staff has reviewed the documents and concurs with FPL that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would impair the efforts of the utility to contract for goods or services on favorable terms and would harm utility customers' competitive business operations.

Therefore, staff recommends that FPL's request for confidential classification of Document Nos. 02236-14 and 02495-14 be approved.
