(and all fall-out changes that result from such determinations):

(a) Determining that the proper rate case expense amount includes amounts requested

by the Utility as set out in Table 11 of the Order in the column titled "Utility

Revised Actual and Estimated" (less the \$4,000 filing fee that was included twice),

plus the rate case expense associated with this formal administrative hearing, and

WHEREFORE, the Utility hereby protests and objects to Order No. PSC-14-0283-PAA-WS as to

the specific issue raised in this Petition, and petitions the Commission to conduct a formal evidentiary

hearing, under the provisions of Section 120.57(1), Florida Statutes.
