RE:	Recommendation to Office of the General Counsel - Docket No. 140109-TX – Petition for review and reversal of Neustar's denial of growth numbering resources in the Seagrove Beach rate center, by Knology of Florida, Inc. d/b/a WOW! Internet, Cable and Phone.

On May 19, 2014, Knology of Florida, Inc. d/b/a WOW! Internet, Cable and Phone (Knology) filed a request for additional numbering resources from the Number Pooling Administrator (NeuStar) for the Seagrove Beach rate center. Knology requested one full NXX to provide a Local Rounting Number (LRN) for the installation of a new switch in the Seagrove Beach (PNSCFLWAX4Y) rate center. On May 19, 2014, Knology's request for additional numbering resources was denied because it did not meet the utilization criteria.

On May 27, 2014, Knology filed a petition requesting that the Commission overturn NeuStar's decision. In accordance with Section 2.07C.5.e of the Administrative Procedures Manual (APM), staff has examined the Knology petition and has determined the following:

- The carrier has demonstrated that it has customers in need of numbering resources;
- 2) The carrier has shown that it will be unable to provide services to these potential customers because of NeuStar's denial of the numbering resources; and
- 3) Customers will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.

Since the three criteria of Section 2.07C.5.e of the APM have been met, please prepare an administrative Proposed Agency Action Order to be issued within seven business days of this memorandum (June 17, 2014), as outlined in the APM expedited code denial process. NeuStar should be directed to provide Knology the needed numbering resources to meet its customer's LRN needs in the Seagrove Beach (PNSCFLWAX4Y) rate center.
