T-Mobile South LLC ("T-Mobile"), pursuant to Section 364.183(1), Florida Statutes, hereby claims that the information contained in T-Mobile's FCC Form 481 filing contains confidential customer and trade secret information that should be held exempt from public disclosure. Pursuant to Rule 25-22.006(5), Florida Administrative Code, the attached sealed envelope contains the document with the confidential information highlighted; two copies of the redacted Form 481 are attached. Given the lack of jurisdiction over T-Mobile as a wireless ETC due to the 2011 amendment to section 364.011, Florida Statutes, T-Mobile has filed the necessary documentation with the FCC for its annual federal USF high cost certification for those areas in which T-Mobile has been designated to serve as an ETC in the State of Florida. As a courtesy, T-Mobile is also filing a copy of its Form 481 in this docket so that the Commission will be apprised of T-Mobile's continued compliance and commitment to serve as an ETC in Florida.
