#### FLORIDA CITY GAS COMPANY'S <u>PREHEARING STATEMENT</u>

Pursuant to the requirements of the Order on Procedure, Order No. PSC-14-0083-PCO-GU, Florida City Gas hereby submits its Prehearing Statement.

A. <u>Known Witnesses</u>

Florida City Gas intends to offer the 2013 true-up testimony of Thomas Kaufmann, as filed on April 30, 2014, as well as the true-up factor testimony of Mr. Kaufmann, which was submitted on August 22, 2014.

#### C. Basic Position

Florida City Gas has appropriately calculated its true-up amounts and purchased gas adjustment factor as shown in the Company's positions on Issues 1-5.

### D. – F. <u>Issues</u>

Florida City Gas' position on the issues identified are as follows:

<u>Issue 1:</u> What are the final purchased gas adjustment true-up amounts for the period January 2013 through December 2013?

Florida City Gas: An over-recovery of \$1,332,078.

<u>Issue 2:</u> What are the actual/estimated purchased gas adjustment true-up amounts for the period January 2014 through December 2014?

Florida City Gas: An under-recovery of \$1,069,341.

<u>Issue 3:</u> What are the total purchased gas adjustment true-up amounts to be collected during the period January 2015 through December 2015?

<u>Florida City Gas:</u> An over-recovery of \$262,737, for a true-up refund factor of 00.606 cents per therm.

- <u>Issue 4:</u> What are the levelized purchased gas cost recovery (cap) factors for the period January 2015 through December 2015?
- <u>Florida City Gas:</u> Based on the winter months of October through March the appropriate (cap) factors are 87.841 cents per therm before the regulatory assessment fees are added and 88.283 cents per therm with regulatory assessment fees included.
- <u>Issue 5:</u> What should be the effective date of the new purchased gas adjustment charge for billing purposes?
- <u>Florida City Gas:</u> The factors should be effective for all meter readings on or after January 1, 2015 and should apply for bills rendered for meter readings taken between January 1, 2015 and December 31, 2015.
- G. <u>Stipulated Issues</u>

Florida City Gas is not a party to any stipulations at this time, although it believes that it should be possible to reach a stipulation on each of the above issues as they relate to Florida City Gas.

H. <u>Pending Motions</u>

None at this time.

I. <u>Pending Confidentiality Requests</u>

Florida City Gas has no pending requests for confidentiality.

# J. <u>Compliance With Order on Procedure</u>

Florida City Gas believes that this Prehearing Statement fully complies with the requirements of the Order on Procedure.
