PGS's Statement of Basic Position:

The Commission should approve PGS's final PGA true-up amount of \$3,036,213 under-recovery for the period January 2013 through December 2013; its actual/estimated PGA true-up amount of \$3,655,983 over-recovery for the period January 2014 through December 2014; and its levelized PGA (cap) factor of \$0.98354per therm for the period January 2015 through December 2015. (Floyd)

Generic Purchased Gas Adjustment Issues

ISSUE 1: What are the final purchased gas adjustment true-up amounts for the period January 2013 through December 2013?

PGS: \$3,036,213 under-recovery (Floyd)

ISSUE 2: What are the actual/estimated purchased gas adjustment true-up amounts for the period January 2014 through December 2014?

PGS: \$3,655,983 over-recovery (Floyd)

ISSUE 3: What are the total purchased gas adjustment true-up amounts to be collected during the period January 2015 through December 2015?

PGS: \$619,770 over-recovery (Floyd)

ISSUE 4: What are the levelized purchased gas cost recovery (cap) factors for the period January 2015 through December 2015?

<u>PGS</u>: \$0.98354 per therm (Floyd)

ISSUE 5: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

PGS: The charge should be effective beginning with the specified purchased gas cost recovery cycle and thereafter for the period January 2015 through December 2015. Billing cycles may start

before January 1, 2015, and the last cycle may be read after December 31, 2015, so that each customer is billed for twelve months regardless of when the adjustment charge became effective. (Floyd)
