Marty,

I left a message at your office, but I wanted to give you a heads up and follow up with an email. By Order No. PSC-13-0647-PAA-WU, issued on December 5, 2013, in the docket stated above, the Commission approved a rate increase for People's Water Service Company of Florida, Inc. The tariffs became effective on January 1, 2014.

Pursuant to Section 367.0816, Florida Statutes, the approved rate case expense is amortized over four years. Therefore, the reduction in water rates to remove rate case expense will be due on January 1, 2018. If the Utility files the reduction in conjunction with a price index or pass-through rate adjustment, separate data should be filed for the price index, pass-through increase or decrease, and the reduction in rates due to the amortized rate case expense.

I will forward you a reminder of the rate reduction in late 2017 so that the Utility can file the revised tariff sheets prior to January 1, 2018. Please feel free to contact me if you have any questions.
