Windstream Holdings, Inc. (“Windstream”), Intellifiber Networks, Inc., McLeodUSA Telecommunications Services, LLC, Network Telephone Corp., Paetec Communications, Inc., Talk America, Inc., The Other Phone Company, US LEC of Florida, LLC, Windstream Communications, Inc., Windstream Florida, Inc., Windstream KDL, Inc., Windstream Norlight, Inc., Windstream NTI, Inc., Windstream NuVox, Inc. (collectively, the “Windstream Licensees”); Communications Sales and Leasing, Inc. (“CSL”), Talk America Services, LLC (“TAS”) (Windstream, the Windstream Licensees, CSL, and TAS collectively, the “Parties”), by their undersigned counsel, hereby supplement the notification filed by the Parties dated September 12, 2014.

The Parties clarify that the customers of Windstream Florida, Inc. will not be transferred to TAS as a result of the Transaction described in the notice letter filed September 12, 2014. Only the customers of the competitive local exchange and interexchange subsidiaries will be transferred to TAS (*i.e.*, Intellifiber Networks, Inc., McLeodUSA Telecommunications Services, LLC, Network Telephone Corp., Paetec Communications, Inc., Talk America, Inc., The Other Phone Company, US LEC of Florida, LLC, Windstream Communications, Inc., Windstream KDL, Inc., Windstream Norlight, Inc., Windstream NTI, Inc., Windstream NuVox, Inc.). No customers will be transferred from Windstream Florida, Inc. (an ILEC) to TAS. Rather, Windstream Florida, Inc. will continue to serve all of its existing customers following the Transaction. We apologize for any confusion.
