



CUSTOMER NOTICE

Section 367.0816, Florida Statutes, requires that rate case expense be recovered over a period of four years. The statute further requires that the rates of the utility be reduced immediately at the conclusion of the four years by the amount of rate case expense previously included in the rates.

Water Management Services, Inc. was granted a rate increase by the Florida Public Service Commission in Order No. PSC-11-0010-SC-WU, issued on 01/03/2011 in Docket No. 100104-WU. The four-year recovery period for rate case expense will expire on 02/21/2015. Effective 02/22/2015 the rates will be reduced as follows:
