**Petitioner's Withdrawal of Request for Confidential Classification for Certain Information in Document Nos. 01221-15 and 01743-15**

On March 2, 2015, and March 31, 2015, the Florida Division of Chesapeake Utilities Corporation (Chesapeake) filed requests for confidential classification for Document Nos. 01221-15 and 01743-15, respectively. These documents contained responses to staff's second and third data requests issued to Chesapeake. The materials in the documents for which Chesapeake sought confidential treatment related to information that is not publicly disclosed. Staff reviewed the documents and concurred with Chesapeake that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would be harmful to the competitive business operations of Chesapeake [see Document Nos. 01265-15 and 01764-15].

On April 10, 2015, Chesapeake determined that certain information in Document Nos. 01221-15 and 01743-15 no longer qualified as "proprietary confidential business information" and withdrew its requests for confidential classification for the following:

Document No. 01221-15:

Data Response 1(c), highlighted amount(s) in line 5 of third paragraph (\$0.107 per therm), and Data Response 3, highlighted amounts in line 5 of first paragraph (4.05% and 6.44%).

Document No. 01743-15:

Data Response 2(c), page 7, highlighted amount in line 4 of numbered paragraph 5 (\$0.107), highlighted amount in line 1 of numbered paragraph 6 (\$0.107) and in line 2 of numbered paragraph 6 (\$4,803,000).

Therefore, staff recommends that the requests of Chesapeake for confidential classification of Document Nos. 01221-15 and 01743-15 be approved, with the exception of the information noted above for which Chesapeake has withdrawn its request for confidential treatment.
