
Dear Ms. Stauffer:

TAMPA ELECTRIC COMPANY AND SUMTER ELECTRIC COOPERATIVE, INC.


In Order No. PSC-94-1397-FOF-EU issued on November 16, 1994 in Docket No. 940947-EU the Commission approved the territorial agreement entered into by and between Tampa Electric Company and Sumter Electric Cooperative, Inc. Section 4.1 of said Agreement calls for an annual report from Sumter Electric Cooperative, Inc. providing the status of the Agreement and any modifications proposed in the Agreement.

This is to advise the Commission that the subject territorial agreement remains in full force and effect and that no modifications have been proposed in such agreement nor have the parties encountered any disputes concerning the provisions of such agreement.

The parties will advise the Commission to the extent that any changes are proposed and will petition the Commission to resolve any disputes which may arise concerning the provisions of the Agreement which the parties are unable to resolve.
