### NI PACOLET MILLIKEN UTILITIES, LLC'S REQUEST FOR CONFIDENTIAL CLASSIFICATION

Ni Pacolet Milliken Utilities, LLC ("Ni Pacolet Milliken") files this Request for Confidential Classification pursuant to Section 367.156, Florida Statutes, and Rule 25-22.006, Florida Administrative Code and states:

1. By letter dated May 8, 2015, the Staff of the Florida Public Service Commission

requested the financial statement of any entity relied upon by Ni Pacolet Milliken for funding. In

response, Ni Pacolet Milliken is producing the consolidated financial statements for Pacolet

Milliken Enterprises, Inc. and its subsidiaries for the years ended December 2014 and 2013.

2. Section 367.156 (1), Florida Statutes, states:

Upon request of the public utility or other person, any records received by the commission which are shown and found by the commission to be proprietary confidential business information shall be kept confidential and shall be exempt from s. 119.07(1).

3. The term "proprietary confidential business information" is defined in Section

367.156 (3), Florida Statutes:

Proprietary confidential business information means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or COM \_\_\_\_\_ AFD \_\_\_\_\_ APA \_\_\_\_\_ ECO \_\_\_\_\_ ENG \\_\_\_\_ GCL \_\_\_\_\_ GCL \_\_\_\_\_ IDM \_\_\_\_\_ TEL \_\_\_\_\_ CLK \_\_\_\_ administrative body, or private agreement that provides that the information will not be released to the public. Proprietary confidential business information includes, but is not limited to:

(a) Trade secrets.

- (b) Internal auditing controls and reports of internal auditors.
- (c) Security measures, systems, or procedures.

(d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms.

(e) Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information.

(f) Employee personnel information unrelated to compensation, duties, qualifications, or responsibilities.

4. The confidential documents identified above are entitled to protection under Section 367.156(1), Florida Statutes and meet the definition in Section 367.156(3), Florida Statutes, because each document includes proprietary and confidential competitive business information and contractual data and competitively sensitive commercial information, the disclosure of which would adversely impact the competitive business interests of Ni Pacolet Milliken and its parent company, Pacolet Milliken Enterprises, Inc. Both Pacolet Milliken Enterprises and Ni Pacolet Milliken treat the information for which protection is sought as confidential, and neither has voluntarily disclosed the information to the public.

5. Attached to this Request and incorporated herein for all purposes are the following supporting exhibits:

• <u>Confidential Exhibit A</u>: A sealed envelope containing a copy of Pacolet Milliken Enterprises, Inc.'s financial statements, for which for which Ni Pacolet Milliken requests confidential classification herein. With the exception of the cover sheet shown on Attachment B, the entire document is confidential. The document is an original archive copy identified by document control number and cannot be copied or highlighted.

Before me, the undersigned authority, personally appeared RICK S. THOMPSON, who being first duly sworn, on oath deposes and states:

1. My name is Rick S. Thompson. I am over the age of 18 years old and I have been authorized by Ni Pacolet Milliken Utilities, LLC and Pacolet Milliken Enterprises, Inc. to make this affidavit. I have personal knowledge of the matters stated herein.

2. I am the Chief Financial Officer, Secretary and Treasurer of Pacolet Milliken Enterprises, Inc., the parent company of Ni Pacolet Milliken Utilities, LLC. My business address is 105 Corporate Drive, Suite A, Spartanburg, South Carolina, 29303. In this capacity, I am familiar with the financial statements that are the subject of this Request for Confidential Classification.

3. The consolidated financial statements requested by and provided confidentially to Commission Staff belong to Pacolet Milliken Enterprises, Inc., the parent company of Ni Pacolet Milliken, LLC, the entity that will control Ni Florida, LLC. Pacolet Milliken Enterprises is a privately-held, family-owned company that guards the confidentiality of its financial statements

and controls access to them. Each copy is tracked by control number, and copying of the document is prohibited. Internally, only the company's officers may review the financial statements. External review is strictly limited, and is tracked and controlled by the company's Finance Committee. Access to the financial statements is provided, subject to a strict confidentiality agreement, only when necessary for the company's operations or required by law.

4. Pacolet Milliken Enterprises' private financial statements comprise competitively sensitive and confidential business information that belongs exclusively to the company. The information requires confidential classification because it reveals data concerning the company's confidential balance sheet and other proprietary confidential information belonging to the company and its subsidiaries, including contractual terms, credit facilities, management and investment strategy, structure of company operations, and plans for future growth. If disclosed, this information would adversely impact the competitive business interests of the company and its subsidiaries, and otherwise harm them by revealing the terms and conditions under which they have entered into certain business agreements, as well as the relative strength or weakness of their current finances. Disclosure of this information also would impair the ability of the company and its subsidiaries to contract for goods or services and enter into other contracts on favorable terms.

5. The information identified in Exhibit A and Exhibit C to the Request for Confidential Classification is intended to be and is treated as confidential by Pacolet Milliken Enterprises, Inc. and Ni Pacolet Utilities, LLC, and has never been publicly disclosed.
