Good afternoon all,

On behalf of Martha, there is one pressing issue we have just encountered and need corrected. It is required for the hearing that we have both redacted copies and "yellow copies" (unredacted copies with the confidential portions highlighted in yellow and filed as confidential with the Clerk's Office) that match in both form and in substance. For certain pre-filed exhibits and testimony we have copies that do not match and this needs immediate correction.

It appears the "yellow copies" we currently have were filed shortly after the depositions were taken, with the redacted copies filed sometime after additional confidentiality requests had come in. However, no updated corresponding "yellow copies" were sent to match the redacted versions.
