Dear Ms. Stauffer:

This letter is to request that the Florida Public Service Commission ("Commission") submit a letter to the Federal Communications Commission ("FCC") and the Universal Service Administrative Company ("USAC") certifying that AT&T Florida is in compliance with all provisions of Section 254(e) of the Telecommunications Act.

The amount of federal high-cost support AT&T Florida will receive in 2016 will be used for the services and functionalities outlined in 47 C.F.R. §54.101(a) and, as the attached affidavit shows, AT&T Florida certifies that it will only use the federal high cost support it receives for the provision, maintenance, and upgrading of facilities and services for which such support is intended.

AT&T Florida respectfully requests that the Commission accept this letter and the attached affidavit as self-certification that AT&T Florida is in compliance with 47 U.S.C. § 254(e) and issue a letter to the FCC and USAC certifying that AT&T Florida used its high-cost support in the preceding year (2014) and will use its high-cost support in the coming calendar year (2016) in compliance with Section 254(e) of the Act and therefore is eligible to receive federal high-cost support in 2016.
