Pursuant to Section 367.156 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Utilities, Inc. of Sandalhaven (Sandalhaven or utility) requests confidential classification of certain highlighted information on Document No. 05031-15.

Staff reviewed Sandalhaven's confidentiality request. Document No. 05031-15 contains information that is part of Sandalhaven's Federal income tax returns which are treated by the utility as private and confidential and are not subject to public disclosure. The parent company, Utilities, Inc., is a privately held company and has not made its financial statements and tax filings available for public inspection, the disclosure of which would adversely impact Sandalhaven's competitive business interests. In staff's opinion, the request meets the criteria for confidentiality set forth in section 367.156 Florida Statutes. Therefore, staff recommends that the request for confidentiality of certain information in the context in which it is presented in Document No. 05031-15 be approved.
