Staff reviewed Sandalhaven's confidentiality request. In staff's opinion, the request meets the criteria for confidentiality set forth in section 367.156 Florida Statutes. Therefore, staff recommends that the request for confidentiality of certain information in the context in which it is presented in Document No. 03766-15 be approved.
