2           **CHAIRMAN GRAHAM:** Item No. 5.

3           **MS. AMES:** This is Leslie Ames on behalf  
4 of Commission staff. Item 5 is an initiation  
5 of a show cause proceeding against Sun-Tel  
6 USA, Inc., for failing to keep a current  
7 Florida corporate registration, failing to  
8 file updated contact information with the  
9 Commission Clerk, failing to submit quarterly  
10 Lifeline data, and for failing to provide the  
11 Commission access to company records.

12           Staff is recommending the Commission order  
13 Sun-Tel to show cause in writing within 21 days  
14 of the date of the order why it should not be  
15 penalized \$2,000 or its certificate and ETC  
16 designation be canceled for its apparent  
17 violations. Sun-Tel should be ordered to come  
18 into compliance with all statute and rules it  
19 is currently in violation of in order to  
20 maintain both its CLEC certificate and ETC  
21 designation. If Sun-Tel fails to respond or  
22 comply with the show cause order and/or remit  
23 the penalty, the facts should be deemed  
24 admitted and the company's certificate and ETC  
25 designation should be canceled. Staff is
