I am writing to the commission reference Docket No. 1501 02-SU, Utilities, Inc. of Sandalhaven. The requested rate increase of Utilites Inc. of Sandalhaven is unnecessarily excessive. I say this because it wreaks of a profit-making scheme. The increase proposed amounts to an absurd 138%. This is absurd because any costs caused by the flaws, maintenance or use of the retention site mentioned below should not be passed on to the consumer. Our neighbors, The Fiddlers Green Condo Association, had to contact the Charlotte County Board of Health and have Utilites Inc. cited for percolating into the ground nearly double their permitted amount. They stated that, "This resulted in effluent from the plant on our streets and ditches. They have not been a good neighbor and in fact tried to mislead our board that they were in compliance. They were cited by the EPA for non-compliance. Giving this rate increase would be rewarding them for not adhering to their permit." Additionally, the base use amount is extremely unfair to owners who are seasonal and typically use the service for waste less than 50% of the year. Again the amount requested is absurd and out of line. Profit making is understandable and perhaps an increase to bump up performance and an increase commensurate with the U.S. cost of living would result in an acceptable rate hike, but 138% increase cannot and should not be granted.
