**NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION  
REGARDING PORTIONS OF DUKE ENERGY FLORIDA, LLC'S  
RESPONSES TO STAFF'S FIRST DATA REQUEST**

Duke Energy Florida, LLC (“DEF” or the “Company”), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request Confidential Classification of confidential portions of DEF’s Response to Staff’s First Data Request filed contemporaneously with this notice. Confidential documents have been filed with the clerk and the redacted versions have been filed as part of DEF’s Response to Staff’s First Data Request. Specifically, portions of DEF’s Response to Staff’s First Data Request, question Nos. 1 and 2, contain confidential business information relating to specific contractual lighting product prices. The disclosure of that information to the public would adversely impact DEF’s competitive business interests. Disclosure of that information to the public would also adversely impact the competitive business interests of product suppliers.

A highlighted copy of the above-referenced confidential documents labeled as Exhibit A, has been filed under a separate cover letter.

Pursuant to Rule 25-22.006(3)(a)(1), DEF will file its Request for Confidential Classification
