- (1) Section 367.091, F.S., requires that rates, charges, and customer service policies be approved by the Commission. The Commission has authority to establish, increase, or change a rate or charge.
- (2) Since the late 1990s, the Florida Public Service Commission (FPSC) has approved late payment charges ranging from \$2.00 to \$7.00. The purpose of this charge is not only to provide an incentive for customers to make timely payment, thereby reducing the number of delinquent accounts, but also to place the cost burden of processing delinquent accounts solely upon those who are cost causers.
- (3) The FPSC has approved late payment charges in the following Orders:

- (4) In support of the Applicants request, provided is the cost justification required by Section
  - 367.091, F.S.:

(5) The Applicants utilizes an outside vendor for all customer service, billing, collection, service order generation and dispatch, etc. For the 12 month period, approved late fees were applied as part of the billing/charge calculation process to the applicable regulated utilities with FPSC approved late payment fees. On average, the outside vendor's labor cost was \$0.13 per account to apply late fee. For the 12 month period, notices were mailed to 4,776 customers. Currently, the outside vendor invoices the regulated utilities \$0.30 plus postage for each notice mailed. (\$0.30 + \$0.49 = \$0.79). For the 12 month period, 460 disconnect service orders were generated

to the field. For the 12 month period, 241 customers paid and were reconnected. Reconnect

fee was applied to the accounts through the service order process.

(6) The following information is for the combined privately owned utility companies. For the 1 year reporting period:

Total Accounts Billed = 43,396 Late Fees applied = 9,442 accounts (late fee applied to 21.7% of eligible accounts) Notices Mailed = 4,776 accounts (50% of customers pay after late fee is applied OR are below the minimum amount past due to qualify for a letter to be mailed) Disconnect Service Orders = 460 accounts (90% of customers who received a notice paid OR made payment arrangements to avoid disconnection) Reconnect Service Orders = 241 accounts (This represents 52% of accounts disconnected)

- (7) These costs listed above are only for the processing costs, they do <u>not</u> include any field related costs for USWC. These would be recovered through the other Miscellaneous Service Charges, such as the (1) Initial Connection Charge, (2) Reconnection Charge, and (3) Violation Reconnection Charge.
- (8) For the Returned Check (NSF) charge, these charges are authorized under Section 68.065, F.S., which allows for the assessment of charges for the collection of worthless checks, drafts, or orders of payment. This will not apply to Harbor Waterworks, Inc. since that Applicant already has a FPSC authorized charge. As currently set forth in Sections 832.08(5) and 68.065(2), F.S., the following NSF charges may be assessed:
  - 1. \$25, if the face value does not exceed \$50,
  - 2. \$30, if the face value exceeds \$50 but does not exceed \$300,
  - 3. \$40, if the face value exceeds \$300,
  - 4. or five percent of the face amount of the check, whichever is greater.
- (9) The FPSC has consistently approved these charges in prior Orders. (See Order Nos. PSC-10-0364-TRF-WS, PSC-10-0168-PAA-SU) Furthermore, NSF charges place the cost on the cost-causer, rather than requiring that the costs associated with the return of the NSF checks be spread across the general body of ratepayers.
- (10) The Applicants respectfully request that the FPSC approve their requests for approval of Late Payment Charges and Return Check (NSF) Charge and Request for Approval of Amendment to Tariff Sheets for Miscellaneous Service Charges consistent with past FPSC practice. (Note: Harbor Waterworks, Inc. currently has a FPSC NSF charge)
