Request for Confidential Classification for Document No. 00704-16

On February 4, 2016, Peoples Gas System (Peoples) filed a request for confidential classification for Document No. 00704-16. This document relates to Peoples petition for approval of a special contract with United Parcel Service, Inc. The information in the document for which Peoples seeks confidential treatment relates to its Letter of Authorization addendum (Exhibit A) and its cost of service study (Exhibit C), from which the rate could be arithmetically determined and could be used by others to gain unfair competitive advantage in the market and hamper Peoples' efforts to contract for goods and services on favorable terms. Staff has reviewed the document and concurs with Peoples that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm the competitive business operations of Peoples.

Therefore, staff recommends that the request by Peoples for confidential classification of Document No. 00704-16 be approved.
