> Re: Notification of *Pro Forma* Assignment of Certificate to Provide Alternative Vendor Access Service from Mobilitie, LLC to FL Network Transport, LLC

Dear Sir or Madam:

Mobilitie, LLC ("Mobilitie," or "Assignor") and FL Network Transport, LLC ("FL Network Transport," or "Assignee") (collectively the "Parties"), by undersigned counsel, hereby notify the Florida Public Service Commission ("Commission"), of the *pro forma* assignment of Mobilitie's Certificate to Provide Alternative Vendor Access Service to FL Network Transport ("Transaction").

It is the Parties' understanding that Commission approval is not required for the Transaction pursuant to Fla. Stat. § 364.33. Accordingly, the Parties submit this letter for informational purposes only to ensure the continuing accuracy of the Commission's records. The Parties respectfully request that the Commission update its records, website, and other information as appropriate to reflect that FL Network Transport will hold the certificate following completion of the Transaction. The Parties intend to complete the assignment as soon as any required regulatory approvals are obtained.

I. DESCRIPTION OF THE PARTIES

Mobilitie is a limited liability company organized under the laws of the State of Nevada. Mobilitie designs, builds, and operates network and infrastructure to deliver optimal wireless coverage. Mobilitie's complete wireless infrastructure solutions include funding, designing, building, operating, and maintaining neutral host outdoor and indoor distributed antenna systems (DAS), small cells, Wi-Fi, and communication towers. On December 11, 2006, Mobilitie was authorized to provide alternative vendor access service within the State of Florida. Mobilitie is authorized to provide competitive local exchange, interexchange, and/or backhaul transport telecommunications services pursuant to registration, agency order, or on a deregulated basis in all fifty states, and the District of Columbia. Mobilitie's headquarters is located at 2220 University Drive, Newport Beach, California 92660.

B. FL Network Transport, LLC

FL Network Transport is a Delaware limited liability company with its principal business address at 925B Peachtree Street NE, Suite 710, Atlanta, Georgia 30309. FL Network Transport is a whollyowned, indirect subsidiary of Mobilitie.

II. DESCRIPTION OF THE TRANSACTION

For business and operational reasons, Mobilitie is transferring its Certificate to Provide Alternative Vendor Access Service to FL Network Transport.

Following closing, FL Network Transport will continue to offer the same services as Mobilitie to its customers in the State of Florida. Furthermore, Mobilitie's management will continue to be responsible for the day-to-day operations of FL Network Transport's business.

III. PUBLIC INTEREST STATEMENT

The Parties submit that the Transaction described herein serves the public interest. The Transaction promotes competition among telecommunications carriers by providing FL Network Transport with the opportunity to strengthen its competitive position in order to accelerate the growth of the business. The Parties anticipate that the Transaction will enable them to deliver greater value and variety of services to their customers.

The Transaction will be transparent to customers, and will not result in the discontinuance, reduction, loss, or impairment of service to customers. Rather, as noted, it will enable the Parties to make available a greater variety of high-quality, innovative services to their customers.
