2           **CHAIRMAN BROWN:** Item 3. Good morning.

3           **MS. BUYS:** Good morning, Commissioners.

4 I'm Penelope Buys with Commission staff.

5           Item 3 is staff's recommendation on the  
6 application for transfer of the water system and  
7 Certificate No. 654-W from Black Bear Reserve Water  
8 Corporation to Black Bear Waterworks in Lake County.

9           Black Bear Reserve is a Class C utility  
10 serving approximately 292 water customers.  
11 Wastewater treatment is provided by septic tanks.

12           Staff recommends that the Commission grant  
13 the transfer of the water system and the  
14 certificate. Staff additionally recommends net book  
15 value of \$285,371 for transfer purposes, no  
16 acquisition adjustment, and a convenience charge of  
17 \$2.60 for customers to pay their bills by debit or  
18 credit card online or over the phone.

19           Black Bear waived the 60-day statutory  
20 timeframe for the Commission's decision on the  
21 proposed convenience charge. There has been no  
22 customer correspondence regarding this docket.  
23 Staff is prepared to answer any questions.

24           **CHAIRMAN BROWN:** Thank you.
