Dear Governor Scott,

I am writing on behalf of our Summertree community to ask for your intervention in our ongoing twenty five year battle with Utilities Inc. of Florida. Our concerns surround the very poor secondary quality water issues as well as continuous rate increase requests.

As of December 30, 2015, we the citizens of Summertree, New Port Richey, Florida have once again started to speak out and unite against another proposed rate increase.

FPSC Docket # 150269 is a two phase rate increase with the final rate of our water at \$6.58 per thousand gallons. This is in addition to the double sewer rate (based upon water consumption) and also service fees for residential water service and sewer service amounting to \$25.43.

On December 7, 1992, FPSC Docket Order #25821, UIF imposed their first rate increase and purchased the property. We have fought with Utilities Inc. over the continuing poor secondary water quality issues all these years.

At present, we the residents of Summertree are in full agreement for an <u>Interconnect with Pasco County</u> <u>Utilities to improve water quality</u> that will result in better taste, color and smell of our potable water. But with the continued monopolistic ways of Utilities Inc. and its Corporate Culture to seek more and more rate increases from this 55+ senior community, we cannot abide in this Corporate Ideology of seeking more rate increase on the backs of the residents and ratepayers, while this company takes more of our senior and fixed income dollars out of our community in Pasco County.

It is my fear that with the constant requests for rate increases, soon our community will be the one that falls victim to a decline in our property values and loss of general tax revenue for our county. Our surrounding neighborhoods pay a much lower water and sewer rate to Pasco County, while we pay a much higher rate since Utilities Inc. is a private company. This imbalance will soon affect home sales and property values in Summertree.

We are not asking for a hand out from government, but a helping hand to rid Summertree of this Corporate culture of Utilities Inc. who has burdened the senior residents, Summertree and Pasco County with for too many years.

Please, Governor Scott, support your fellow Floridians, by speaking to the Commissioners at the Florida Public Service Commission and encourage them to <u>vote NO</u> on yet another rate increase with Utilities Inc., and to <u>recommend that Utilities Inc.</u>, for its own best interest, SELL the water and sewer rights TO PASCO COUNTY.
