12 company's requested rate schedules to allow staff and  
13 intervenors sufficient time to adequately investigate  
14 whether the request for rate relief is appropriate. To  
15 date, 28 customers have filed comments regarding the  
16 company's petition.

17           Staff is prepared to answer any questions the  
18 Commission may have.
